- 1 Year support
- 5 years of optional re-occurring support and subscription costs for hardware and software.
- Battery Backup as specified by vendor
- Other as vendor sees important

A funding request will be submitted with E-Rate and all bidders should be E-Rate eligible. The funding for this project may depend on the amount of funding from E-Rate, State of Oregon funding, and local funding. This project may be done in its entirety, partial completion, or the project may not be funded at all. All bidders must submit a letter of authorization from the manufacturer stating that seller is authorized to resale their products and that item will be fully warrantied through seller/manufacture. Potential vendors may make substitutions as necessary with specific details as to the substitution and impact.

- Ongoing/Support Costs—15 points for least cost
- Vendor References and Reputation—Letter of Authorization from Manufacture—15 points
